#### Healthcare (Bill Walsh)

In the House Health Care Committee (HHC) this week we relearned that controversy and debate take a lot of time. HHC spent over an hour over two meetings dealing with HB 2362 before it squeaked through to passage and was sent to Ways and Means (W&M). The bill would require approval from the Oregon Health Authority (OHA) prior to mergers, acquisitions, or affiliations of entities, e.g., hospital mergers, involving significant patient revenue. HHC also passed HB 2517, which requires Coordinated Care Organizations (CCOs) to report prior authorization information to OHA; and HB 2623 that sets a limit, \$105 for 90 day supply, on cost-sharing for insulin. HHC held Public Hearings on HB 3159, requiring providers and insurers to collect data (race, ethnicity, language, disability, sexual orientation and gender identity) on patients and report to OHA, which will set up a system to track this data; HB 3353 OHA to seek federal approval in Medicaid to allow CCOs to spend funds on health equity services in the community; and HB 3231 establishes a State Board of Sign Language Interpreters within OHA. Next week will be busy as HHC carried over eight bills House Bills 2622, 2648, 2327, 3108, 2076, 2359, 2046, and 2958.

Senate Health Care Committee (SHC), working under time pressures, managed to pass the following bills: SB 610 which creates a financial grant program within the Oregon Health Authority (OHA) for doctoral



candidates to provide cultural competency training; <u>SB 850</u> requires that death reports now include housing status to track homelessness; SB 629 allows telepharmacy in remote areas; SB 12 was changed to a study to determine whether it would save money if Public Employees Benefit Board (PEBB) and Oregon Educators Benefit Board (OEB) cover travel costs to Mexico and Canada to fill prescriptions and sent on to W&M; SB 748 requires PEBB, OEB, and private insurers to cover adult disabled children and siblings under certain circumstances; SB 684 would change the rules to settle disputes between providers and the Oregon Medical Board but was moved to an Information Session; SB 699 prohibits grandfathered insurance plans from imposing preexisting condition exclusion; SB 772 requires that naturopathic physicians be paid at the same rate as licensed physicians; SB 168 requires insurance plans to cover fertility and reproductive endocrinology services; SB 157 exempts medical marijuana registry cardholders from paying sales tax on product. Four important drug bills passed: SB 848 establishes an Office of Pharmaceutical Purchasing for bulk purchasing within OHA; SB 763 requires a license from the Department of Consumer and Business Services to do drug business; <u>SB 764</u> stops the alleged "Pay to Delay" pharmaceutical practice; and SB 844 establishes Prescription Drug Affordability Board within DCBS

### Housing (Debbie Aiona and Nancy Donovan)

Last week in Salem some of the major housing bills moved to floor votes in either the House or Senate.

SB 852: The Mortgage Interest Deduction reform passed out of the House and Senate Housing Committees and has been referred to the Senate Finance and Revenue Committee. This important reform would phase out the deduction for the top five percent of taxpayers and reallocate the savings towards affordable homeownership and prevention of homelessness. LWVOR submitted a <u>letter</u> in support. <u>SB 5505</u>: This bill allocates bonding for a wide variety of capital projects, including housing. The Joint Committee in Capital Construction held a



public hearing on April 9. The League submitted a <u>letter</u> in support of \$50 million in General Obligation bonds for development of permanent supportive housing. Studies have shown that pairing supportive services with affordable housing for vulnerable individuals and families not only resolves homelessness and increases housing stability, but also improves health and lowers public costs by reducing the use of publicly-funded crisis services.

HB 2009: The House voted to reinstate Oregon's temporary mortgage payment deferral and protection from foreclosure through June 30, 2021. The bill grants the Governor the authority to extend this foreclosure moratorium twice more in three-month increments. These protections will help keep people in their homes until the economy can recover from the effects of the pandemic.

HB 3184: Funding for a Portland State University study of a state program for long-term rent assistance similar to the federal Section 8 program, advanced to the Ways and Means Committee. Northwest Pilot Project, a Portland non-profit that serves seniors experiencing housing instability or homelessness, piloted a long-term rent assistance program and evaluation that demonstrated the benefits of this type of support.

Tuesday. April 13 marks the next deadline in the Legislative session. By the end of the day on Tuesday, bills must have moved out of their policy committees in their chamber of origin in either the House or Senate and head to their next stop: Ways and Means, Revenue, Rules, or the Floor. Bills that are not ready to meet this deadline will die for the season.

The Senate is scheduled to vote on <u>SB 282</u>, which provides protections for renters after July 1, by instituting a grace period for paying back rent.

The House Committee on Judiciary will hold both a public hearing and possible work session on <u>HB 2367</u> establishing the Right to Rest Act. This bill would remove penalties or fines or arrests for people experiencing homelessness as they eat, sleep, and sit in public, without a safe home to go to. The bill was introduced by <u>Rep. Wlnsvey Campos</u>, Oregon's



youngest legislator and a person who lived with housing instability while growing up.

#### **Human Services (Karen Nibler)**

Public Safety Ways and Means heard a presentation from the Oregon Judicial Department on April 7 and will continue on April 12 and 13. The League did a study on the Oregon Judiciary in 2006 and 2007 which led to support for the OJD Budget since then. This session <a href="https://example.com/HB 5012">HB 5012</a> drew our support again.

The Police Accountability bills were heard in the House Judiciary Committee over 2 days this week. <a href="HB 2162-4">HB 2162-4</a> covered police accreditation, HB 2928-3 prohibits chemical use on riots, <a href="HB 2929-3">HB 2929-3</a> logs police misconduct reports at the Department of Public Safety and Standards and Training, <a href="HB 2930-1">HB 2930-1</a> limits arbitrators, <a href="HB 2932-6">HB 2932-6</a> keeps a database on the use of force in the Oregon Criminal Justice Commission, and <a href="HB 2936-5">HB 2936-5</a> gives the Department of Public Safety Standards and Training (DPSST) the responsibility of background investigations of new hires.

<u>HB 2928</u>-3, regulating the use of tear gas and pepper spray by police against crowds, passed out of committee unanimously and has been referred to Ways and Means. The <u>Fiscal Impact Statement</u> indicates a cost of about \$1.5 million to the Oregon State Police.

HB 3059-1 covered the unlawful assembly of 5 or more persons. Police may order to disperse or arrest for any unlawful activity. HB 3175-2 establishes an online database of disciplinary actions within DPSST. HB 3355-2 covers police or sheriff identification during crowd control. The bills that involve state agency costs were referred to Ways and Means. The last bill involved local costs.

The Senate Judiciary Committee has a long list of proposed bills scheduled for next week, many with amendments that replace the



original bill. This week they passed <u>SB 199 -5</u> on an advance directive form, <u>SB 731-1</u> on tribal police officers, <u>SB 751 -2</u> on discovery to defendants, <u>SB 766</u> on restraining orders to protect victims, <u>SB 778 -2</u> to establish Office of Immigrant and Refugee Advancement, and <u>SB 823 - 1</u> and 2 on notice that firearms may be restricted.

Senate Human Services passed several bills on prohibited discipline in children's programs on April 6. SB 710 -5 defined restraint and seclusion limits in foster care or residential programs along with staff training requirements in the 34 page bill. Other bills covered mental health facilities.

Earlier the committee passed <u>SB 563</u> on a Youth Suicide Intervention and Prevention Advisory Committee within the Oregon Health Authority, and <u>SB 682</u> for an Adult Intervention and Prevention Coordinator in OHA, which was referred to Ways and Means.

<u>SB 680</u> on peer respite treatment and <u>SB 686</u> on telemedicine visits were passed on April 8. <u>SB 755</u> on the BM 110 implementation is still in the Senate Judiciary.

House Behavioral Health considered <u>HB 3377-3</u>, which was a tax on alcohol to be used for prevention and treatment. However, the bill was amended again and passed on April 7.

House Human Services passed <u>HB 2119 -2</u> which transferred the 211 information system to The Department of Human Services and <u>HB 2754</u> on services for domestic violence within the DHS Self Sufficiency program. <u>HB 2544-1</u> proposed funding for Homeless Youth, which was passed and referred to Ways and Means. The League proposed a larger study of needs throughout the state, which was not addressed by the committee. However, the DHS staff reported that the need for a study was recognized and is already in process.
